 - Mapping of national initiatives across continuum of care with emphasis on quality assurance
 - Integration of RD activities across thematic areas, MS and related activities



 - Cross referencing and update of international nomenclatures

Addressing specific area of need for holistic care

- Specialised social services for RD
 - Map access to specialised social services for RD
 - Therapeutic recreational programmes
 - Respite services
 - Other specialised rehab services (e.g. housing)
 - Guidance to MS and other stakeholders on training for social service providers
 - Integration of RD into social policies and guidelines




Integration of RD initiatives (disease-specific, national and international
