### **Examples of Proposals**

- Maximising the expertise available to the teams, to promote the sharing of good practices between MS, exchange the latest outputs, and facilitate discussions between national stakeholders
- Exchanging information sharing the latest progress on our dedicated WPs for CEs, Coding, Specialised social services, genetic testing etc.
- Organising workshops dedicated to several key themes, involving DS participants, and trying to promote opportunities for countries to discuss key issues with those facing similar challenges
- Providing practical hands-on support, with issues such as establishing helplines
- Aim these proposals of support compliment the activities being explored for building capacity across the MS

# Capacity building

Increasing the *quality* and *quantity* of work that an individual/organisation is able to dc





An on-going evidence driven process of strengthening the abilities of individuals, organizations, and/or systems to perform core functions sustainably, and to continue to improve and develop over time.

### Phase II (small groups) – 90 minutes

Participants are divided in 4 thematic groups

Each group elaborates an agreed proposal of support,

TO PRIORITISE THESE ACTIVITIES AND MODALITIES

Facilitators: EUROPLAN Staff

Rapporteurs: EURORDIS and UNEW Staff

#### Phase III (plenary)

Each rapporteur presents the small group conclusions (5 min. per group).

All participants discuss and agree the proposals.
